STATEMENT OF THE OUTPUT (FISSION) OF ENERGY EXCHANGE:

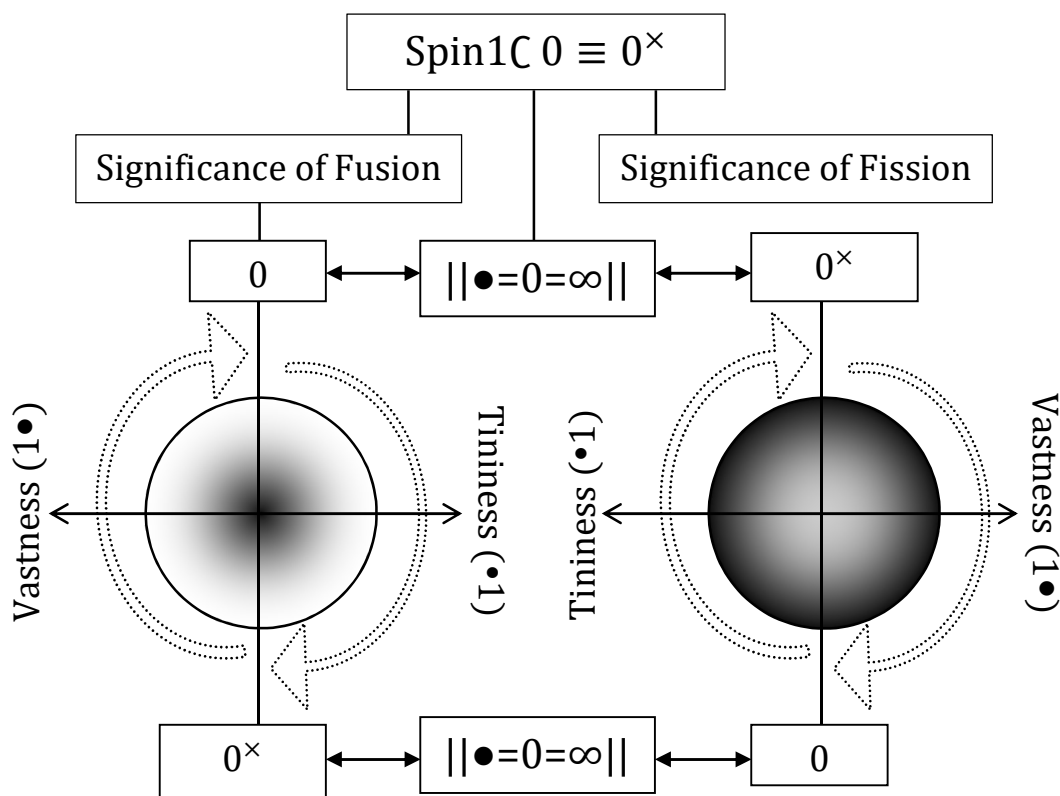

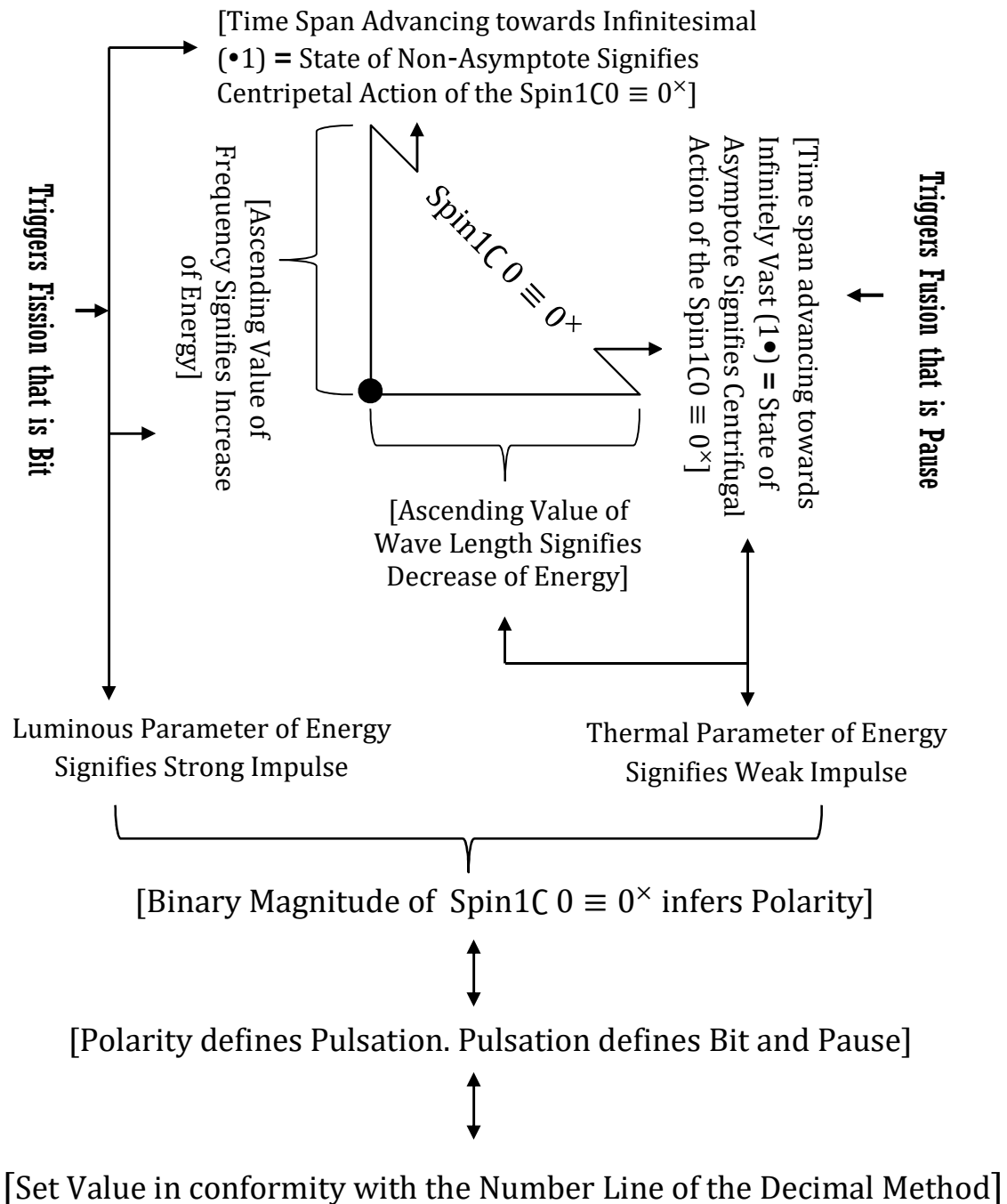

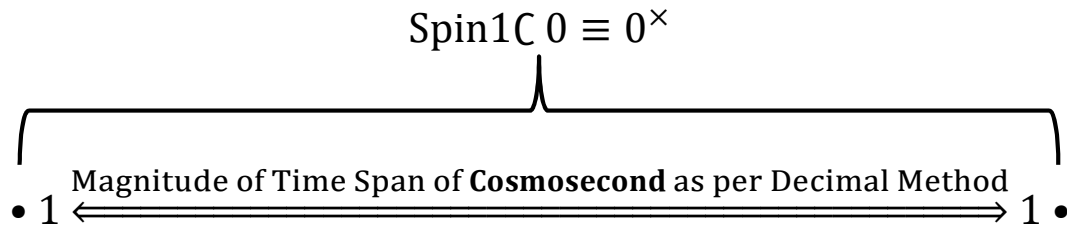
